Any bids received after 3:00 PM November 14, 2013, will not be accepted and will be deemed non-responsive.

Awarded contractors and subcontractors shall have 30 calendar days after the execution of the contract to register and enter into a Memorandum of Understanding (MOU) with the Department of Homeland Security (DHS) E-Verify program.
