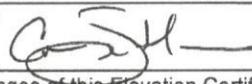

 The elevation listed in section C2h refers to the lowest points of the recessed loading docks on the north side of the building. There are elevated poured concrete stem walls on each side of the loading docks along with a trench drain and storm water system that might prevent any flood water that may enter the loading docks from entering the building. The lowest elevation of equipment servicing the structure, C2(e) is a concrete transformer pad on the north side of the structure. Sub-surface electrical lines most likely run from this structure to the north face of the building.

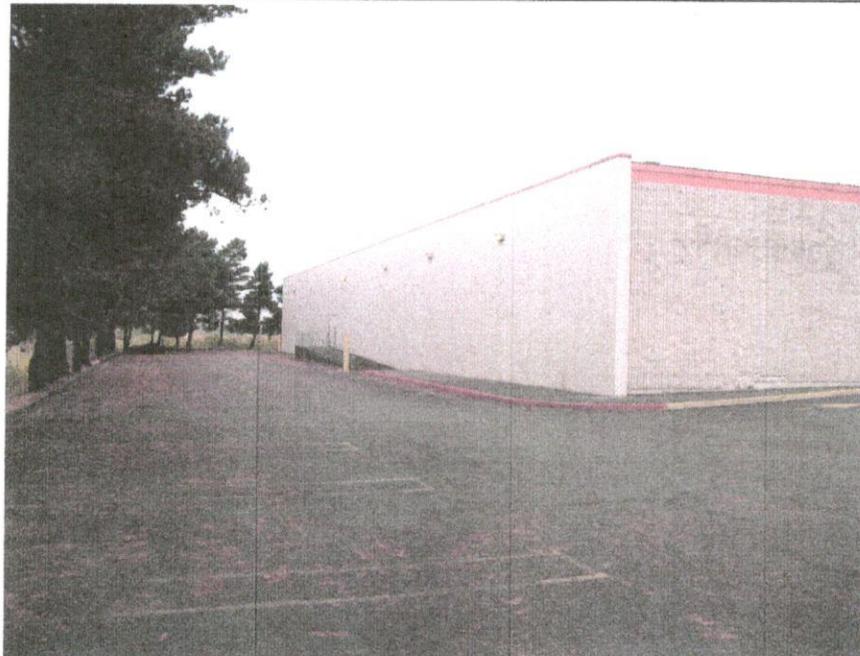
