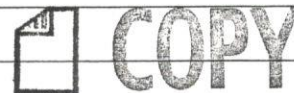

In reference to changes made on the elevation certificate for 1258 SW Sylvenus I offer the following:

The original elevation certificate did not include the revised map/panel numbers and dates. As no technical information was to be changed, the Chehalis Strategic Planner at that time inserted the updates to the map/panel number, dates and flood zone designation number. The elevation certificate refers to the original 1980 FIRM map, numbers and dates, and revisions had been adopted in 2006. The Chehalis Strategic Planner position was eliminated during budget cuts in 2010; therefore, the employee who made the changes is not available to initial the form.
