





General Project Description

The project includes constructing 62 enclosed storage spaces, 14' x 45' and 92 non-enclosed storage spaces that will be covered with standing canopy structure on the 4.15-acre site. The existing house and outbuildings will be demolished as part of this project.

Construction is anticipated for summer of 2023 pending approved fill and grading plans. The applicant would like to have the fill and erosion control plans approved for site filling this summer.

Environmental Review

A previous SEPA Checklist and DNS was issued for this project along with a wetland report through Lewis County. The wetland report included mitigation for filling of the designated wetland via offsite mitigation and creation.

Access & Streets

The site plan currently shows an access off Bishop Road however, we would like to discuss the requirements for this project based on this design versus moving the main access to Sturdevant Road.

Water and Sewer Services

The site will be remote access; therefore, no water or sewer services are anticipated. Water is available in Bishop Road and a sewer manhole is located in Sturdevant Road if services for an office was determined to be added to the project.

Stormwater Facilities


Stormwater will be designed per the 2019 WSDOE stormwater manual. The project plans to utilize an underground stormwater system.



All provisions, conditions, regulations and requirements herein contained will be binding upon the successors and assigns of the grantee. The issuance of this permit does not diminish or negate the grantee's responsibility to comply with any other regulations, standards, licenses or obligations not covered under this permit.
- 2. A *Right-of-Way Disturbance Permit* is for activities that will alter the appearance of or disturb the surface, super-surface or sub-surface of a right-of-way on a temporary or permanent basis.

Damage of any kind to any street, alley, public place, structure or public property resulting from said work by the grantee will immediately be repaired by the grantee at their own sole cost and expense, to the satisfaction of the City.
- 7. The Public Works Director or a designated representative may perform, order, or have done any and all work considered necessary to restore to a safe condition any street, alley, public place or structure which is in a condition that is dangerous to life or property resulting from the grantee's use, activity or work as permitted herein, and upon demand, the grantee will pay to the City all costs of such work and materials.
- 8. The City Council, Public Works Director or designated representative may at any time, change, amend, modify, revoke, annul or terminate this permit and/or any of the conditions herein enumerated so as to conform to any state or federal statute or City regulation pertaining to the public welfare, safety, health, convenience to the public or highway regulations as are, or may hereinafter be enacted, adopted or amended, etc. The City Council, Public Works Director or designated representative may terminate this permit if grantee fails to comply with any such changes or conditions herein enumerated.
- 9. In accepting this permit the grantee, their successors and/or assigns agree to defend, indemnify, and hold harmless the City, its officers, employees, and agents from any and all suits, claims, causes of actions or liabilities caused by, or arising out of, any activities conducted by the grantee resulting from the issuance of the permit.



Arrangements for both have already been made and approved by the Lewis County Sheriff's Office, Chehalis Police Department, and Centralia Police Department.


