General services funded by general revenue sources

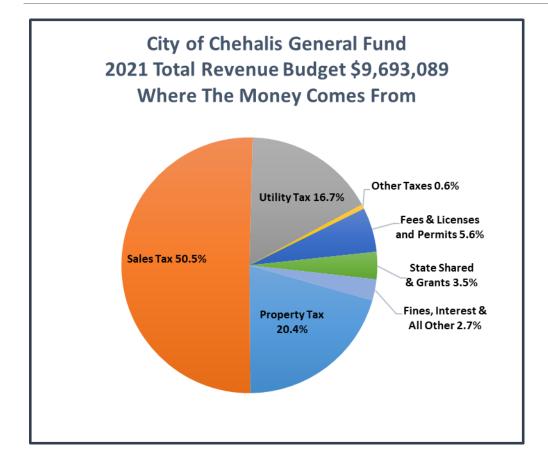

The 2021 Proposed Budget as presented is balanced using \$444,680 of General Fund Reserve (beginning cash)

Police and Fire makes up about 57% of the General Fund Expenditure Budget

General Fund Revenue Summary



87.7% of Total General Fund Revenue is from taxes.

Property Tax – Annual Levy Action

City Council must set levy <u>every year</u> to support the cost of general government

Increasing costs must be balanced by revenues

City must identify all sources of revenues needed to fund programs including the amount of tax levy

Most revenues are external to City control – best estimate

Property taxes may be increased on a limited basis with City Council approval

Property taxes for upcoming year must be certified to the County Assessor

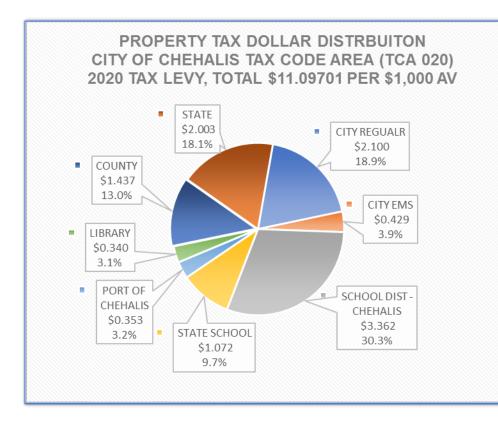
- no later than November 30.

Property Tax – Levy Limit

Property tax levy limit

- Cities with a population of less than 10,000 can increase their levy amount by one percent (1 %) without a vote
- Plus additional levy generated by new construction, annexation & other adjustments added to tax roll
- Chehalis Maximum Statutory Regular (General Fund) Levy Rate
 - Maximum rate \$3.60 minus the Library District levy \$0.50, plus Firefighters' Pension Fund levy at \$0.225, leaving a maximum statutory levy rate at approximately \$3.325 per \$1,000 of assessed valuation.
 - 2020 actual levy rate was \$2.10
- Emergency Medical Services (EMS) Levy
 - Additional levy up to \$0.50 per \$1,000 AV (requires voter approval)
 - May be imposed for 6 years, 10 years, or permanently
 - Chehalis EMS levy expires in 2021 need voter approval for renewal
- City of Chehalis Banked Capacity
 - City has about \$246,000 in banked capacity in 2020 tax year
 - No plans to use banked capacity in 2021

Property Tax Distribution



Several taxing districts/agencies may tax the same property

Tax Code Area 020 2020 total direct and overlapping levy rate is \$11.09701/\$1,000 AV

More than 77% goes to other entities

Chehalis share of typical property tax bill is less then 23% (or \$2.529/\$1000 AV)

2021 Property Tax Levy – Proposed Amount

2021 Regular Levy \$1,648,617.59

- 2020 levy \$1,616,190.00
- 1% increase plus estimated add-ons \$32,427.59

>2021 EMS Levy \$336,409.23

- ° 2020 levy \$330,190.00
- 1% increase plus estimated add-ons \$6,210,23

Amounts including the 1% maximum allowed increase plus other estimated adjustments (i.e. new construction and changes in state-assessed utility valuation) and administrative refunds levy.

2021 Property Tax Levy – Proposed Increase Amount and Percentage

> Total proposed increase over 2020 actual levy is \$21,828.54 or 1.121%.

This does not include current year add-ons such as new construction and changes for state assessed utilities

Estimated tax increase amount for every hundred thousand (\$100,000) of assessed value is about \$2.86

- This applies to the City portion of the property tax
- City of Chehalis has no control over the amounts levied by other agencies.
