SPECIFICATIONS FOR GLOCK GENERATION 5 PISTOLS

The City of Chehalis is accepting bid proposals for Glock Generation 5 pistols for official use by the police department. Delivery date to be within 60 days of bid award.

I. <u>Pistol Standards:</u>		
1. This specification intends to describe the requirements for the Glock pistols and additional required equipment.		
2. Pistols offered in compliance with this specification must be factory produced models and shall not have been used in demonstrative or other service.		
3. Pistols will include seventeen (17) Glock G17 MOS and six (6) Glock G19s. Glock G47 MOS pistols may be substituted for the model G17 pistols.		
4. The pistols shall be based on the newest generation available at time of bid (generation 5).		
5. Pistols will include all cases, magazines, manuals, and accessories as provided by the manufacturer.		
6. Glock OEM FXD sights appropriate for the different pistol models will be included and installed.		
7. Bid amount will include credit for sixteen (16) used Smith and Wesson M&P .40 caliber pistols. These consist of twelve (12) full-size and four (4) compact pistols.		
8. The standard manufacturer's warranty shall apply to all pistols purchased under this specification. The starting date of the warranty shall be the date the pistols are delivered.
