GENERAL REQUIREMENTS

REQUEST FOR BIDS

Sealed Bids will be received by the Chehalis City Clerk at City Hall located at 350 N Market Blvd., Chehalis, WA 98532 until 3:00 pm on Tuesday, August 15, 2017. Bids will then be publicly opened and read. All bids shall be marked on the outside of the envelope, "**Bid for Chip Spreader**."

Bids shall be accompanied by a bid bond of no less than five (5) percent of the total bid. The bid bond shall be executed by a Bidder and surety company licensed to do business in the state of Washington.

Terms, conditions and instructions to the specifications are attached and made part if the requirements. The chip spreader shall include all items necessary for legal and efficient operation whether or not specifically mentioned in the specifications.

GENERAL DESCRIPTION

The equipment requested for this chip spreader will be used for applying calibrated chip rock to oiled roads. The successful bidder shall verify the specification suitability to this application with the successful manufacturer(s).

Only new models in current production and in common usage that will meet or exceed the following requirements will be considered in the award.

COMPLIANCE WITH SPECIFICATIONS

To be eligible for award, bidders must indicate in the space provided adjacent to each item, whether the equipment they are offering meets, exceeds, or deviates from the desired technical specifications (see page 3).

ALTERNATIVES

Bids offering suitable and equivalent alternatives to these specifications may be considered, by providing the full description and specifications of the alternatives that are submitted.

It is understood that no two equipment manufactures design and engineer their products exactly alike. Therefore, minor specification variances from one manufacturer to the next are normal.

City of Chehalis reserves the right to accept or reject any proposed minor variances that appear to serve its best interest.

STANDARD EQUIPMENT

The equipment offered shall include all of the manufacturer's standard equipment for the equipment model offered in addition to the items required by the specifications.

ACCEPTANCE

No part or parts defective in construction or deficient in any of the requirements of these specifications will be considered as being an accepted consequence of the failure of any employee of City of Chehalis to point out said defects prior to acceptance of the equipment by City of Chehalis. Bidder shall include in the bid price the following guarantees or warranties:

Warranty

- a. The successful bidder hereby warrants that for a minimum period of one year, with or without specifically identified warranty exclusions or limitations as provided by the equipment manufacturer(s) from the date the unit is put into service. A copy of the warranties offered with the exclusions and limitations identified shall be provided with the bidder's proposal. The contractor will, at their own expense, and without any cost whatsoever (parts, labor, travel, shipping) to the City, replace all defective design, material or workmanship.
- b. In the event that the successful bidder(s) is on strike at the time of the award of the bid, the City reserves the option to accept another bid from a manufacturer that is not on strike.

METHOD OF AWARD

City of Chehalis also reserves the right to make no award at its discretion.

OPTIONAL PRICING

Bidders are requested to provide optional pricing for some items. This optional pricing may be considered when evaluating who has the low responsible bid, providing a fair comparison can be established. In addition, the bidder may voluntarily offer non-requested options, these will not be

considered in the award process; however, the City of Chehalis reserves the right to avail itself to purchase an option if it appears to be in the City's best interest to do so. Bidders are instructed to price all options fairly with applicable discounts as would be in the base bid.
